## Cox shares writings on Gettysburg

John D. Cox is a writer, speaker, and artist. He was born in New Haven, CT, is a veteran of the United States Air Force, and a former Licensed Battlefield Guide at Gettysburg National Military Park from 2000 to 2009. He has taught classes on Alexander the Great, Ancient Rome, Napoleon, the American Civil War, and the JFK Assassination at grade schools to colleges. He is known as an engaging and animated speaker.

His subject at the November 14 meeting will "Gettysburg: A History for the People," the title of his second book. "Culp's Hill: The Attack and Defense of the Union Flank, July 2, 1863" was his first.

The program will begin at 7:00 p.m., at the historic church, 6731 Golden Valley Road, Golden Valley. Coffee, juice, bottled water, and cookies will be served following the program.



## Recent accessions to the Society

**Crystal Boyd** donated a magazine article about the First Avenue music venue on Seventh Street and First Avenue North. The owner of the establishment is a Golden Valley resident, Dayna Frank. (*Editor's note: The building housing First Avenue was the former Greyhound Bus Depot for Minneapolis.*)

**Pete Palmquist**, of Golden Valley, donated the onion paper copy of a funeral speech by Rev. J. Harrington for John Gearty, dated September 24, 1913. It is five pages long, single-spaced on 8½ x 14" onionskin, used when carbon paper

was used to make copies.

**Keith Westrick** of Fargo, ND, donated a 75th Anniversary bronze coin for the Ewald Brothers Dairy dated 1886-1961, with the statue of Chris Ewald on the backside. The statue was located on the southwest corner of Xerxes Avenue North and Golden Valley Road and was stolen many years ago by thieves who backed a vehicle up to it and broke it loose from the concrete base. The statue was never recovered.

## Board approves construction plans

The board of directors of the Society approved construction plans and specifications prepared by Bob Shaffer, Foundation Architects, Inc., for an addition to the south and east side of the current church building at their October 16 meeting. The addition will allow us to display artifacts that have been collected since the Society began in 1973. Shaffer is asking contractors who may be interested in building our addition to submit bids to his office. Completed so far are soil borings in the footprint of the addition, the removal of nine box elder trees and trimming of several more that could have been hazardous to the new construction.

## Golden Valley organized 127 years ago

Golden Valley became an organized town on December 17, 1886. The first election of village officials was held on March 8, 1887, at the District 21 School. Elected to one year terms were U.R. Wilson, mayor; Michael Ray, James Sweeney and John Scheid, trustees; William Varner, Jr., recorder; and Wil-

liam Varner, Sr., treasurer. Michael Halloran was elected Justice of the Peace and Lucius Daugherty was chosen as constable. Both men were to serve two-year terms. Edward Sweeney was appointed assessor, at a fee of \$3 per day for each day that he spent assessing. (Source: GVHS newsletter of December, 1982).

## Enghauser extended Wright influence on Golden Valley homes

Paul Enghauser, builder who developed much of Tyrol Hills and other areas of Golden Valley died on February 15, 1984 at the age of 75. Stanley Kane, a resident of Golden Valley, in a 1954 article in the North Minneapolis Post, stated that Enghauser was a student of Frank Lloyd Wright. His homes were built to fit into existing landscapes and followed the ranch-type look of Wright’s. His most significant contribution (according to Dr. John Borchert, University of Minnesota Geography professor and former Golden Valley Council member), is the curvi-linear streets that are in much of Golden Valley and can be dated back to Enghauser’s membership on the Golden Valley Planning Commission. Before he was a member in the late 1930’s, the streets were laid out in a straight North, South, East, West manner. (Source: GVHS Newsletter of March, 1984.)
