Richie publishes pictorial history of City of Robbinsdale

The November General Membership Meeting will feature local author Pete Richie and the newest addition to Arcadia Publishing's library, "Robbinsdale." Richie's pictorial history book, released July 7, 2014, uses black and white photographs to showcase Robbinsdale's compelling history.

While serving in the state legislature, Andrew B. Robbins visited the lakes, woods and rolling hills just north of Minneapolis. Inspired by the landscape and potential for development, he purchased 90 acres and created the Robbinsdale Park subdivision in 1887. Robbins worked tirelessly to bring schools, industry and a streetcar line to the area. In 1893 Robbinsdale incorporated as a village bearing his name.

Pete Richie grew up in Robbinsdale and remembers collect-



Program review... Sannes presented details of Union Army volunteers

Darryl Sannes, co-author of the Patriots of Brooklyn book series, was most interesting and educational with a power point presentation about the year 1864 of the Civil War and a map of the Battle of Acton. His presentation included great details about the volunteers of the Union Army such as age, length of service, pay and respective bonuses, the number of volunteers who were killed in battles or died from their wounds and where they are buried. Twenty-three members and guests, students of Civil War history, enjoyed Sannes's presentation.

Exhibition research begins

The Golden Valley Historical Society hired Museology Exhibits and Programs to conduct exhibition research for the Society's museum addition. Funded by a Minnesota Historical and Cultural Heritage Grant, Museology compiled a guide to the resources identified during their research and created an annotated bibliography. A brief overview accompanies each of the topical bibliographies. Topics include: Natural History; American Indian; Settlement; Agriculture;

Business and Industry; Suburban Development; Human Rights; and GLBT People in Golden Valley.

Little attempt has been made in this phase at interpretation. That work will be done during exhibition development as conversations take place between the Golden Valley Historical Society, the community, and the consultant hired to guide the process. Some additional research will undoubtedly be needed as more detailed content is developed. So begins phase two...

Women entered city politics in 1972

With an election coming up very shortly, it's a good time to review the history of women in politics in the Village/City of Golden Valley. Prior to 1972 only men were elected to the Golden Valley City Council. It was November, 1972 that Pat Moberg was elected as the first female city council member. Moberg was later joined by Mary Anderson and followed by Rosemary Thorsen. Anderson was also the first woman mayor of Golden Valley. Gloria Johnson was elected to the city council in 1975 and reelected in 1979. Anderson says, "Gloria Johnson saw her role on the city council as asking hard questions and often being the 'one'

on a 4-1 vote. She said....'I guess my perspective comes from years of facing the council from the audience and maintaining an adversary role'." She was most influential on the council and challenged a developer who wanted to use the land East of Winnetka along Highway 55 to build a big box drug store and super market. Her leadership of the opposition to that development resulted eventually in the current development housing many small businesses on one site. As a result of women in Golden Valley politics in the 1970's and 1980's, other communities began to elect women to their city governments.
